

1. Announcement

The Australian Superbike Championship (hereafter called "ASBK"), will be conducted under the General Competition Rules (hereafter called "GCRs") contained in Motorcycling Australia's (hereafter called "MA") "Manual of Motorcycle Sport" (<u>www.moms.org.au</u>) and as prescribed here within the ASBK Sporting Regulations.

2. General information

All Riders and Teams are reminded that the current COVID-19 environment changes quickly and all in the ASBK paddock should understand that changes and adjustment may occur planning which are outside of ASBK control.

Bump-in from Wednesday afternoon from **4:30pm**, December 2nd for large trucks and **5:30pm** for all teams ASBK Round 2-3 – Wakefield Park Raceway.

ASBK Management Team advises in reference to ASBK Sporting Regulations 2.6 Unofficial Practice Unofficial practice will not be allowed at each respective round venue for the period commencing <u>30</u> days prior to each event. Applying for rounds 2/3 of 2020.

There will be no spectators for ASBK Rounds 2-3 – Wakefield Park Raceway.

3. COVID-19 Environment

All Riders and Teams are reminded that the current COVID-19 environment changes quickly and all in the ASBK

All personnel in the ASBK paddock must follow the 4²m rule.

Competitors and crew are reminded to practice 1.5 social distance at all times.

Please cooperate with all new regulations and adhere to requests from security, ASBK Staff and Officials and Circuit Staff. Any breach of the COVID-Safe restrictions may result in a sporting penalty and/or fines and penalties by government law enforcement.

All teams / riders must nominate an individual to supervise compliance of the covid safe rules for their team.

4. Entries

Entries for ASBK Round 2/3 at Wakefield Park will open on Friday 6th November, 2020 at 5:00pm.

ASBK Round 2/3 is restricted to approximately 100 entries, under the COVID-Safe plan; competitors intending to race the entire ASBK Championship are encouraged to enter as soon as possible to avoid disappointment.

Entries will close on Tuesday, 24 November 2020. Late entries will not be accepted.

The entry prices for Rounds 2-3 will be the same as what was advised for the Winton Grand Finale.



5. <u>Competitor Support Personnel – ASBK Rounds 2 -3 – Wakefield Park Raceway</u>

Superbike – Rider + 4 crew

Supersport – Rider + 3 crew

Supersport 300 / R3 Cup – Rider + 2 crew

Oceania Junior Cup – Rider + 2 crew

Current Valid entrant licence holders will receive 1 entry for the entrant per team. Not applicable to Oceania Junior Cup.

Competitors cross entering an additional class will not receive additional support personnel passes.

Oceania Junior Cup competitors cross entering into Supersport 300 or R3 Cup will receive maximum of 2 x support personnel passes for all classes for the event.

A condition of entry into the circuit will require ALL personnel to register their contact details for the ASBK Register of Attendees. Including name, phone number and email. Please have these details available and ready to add while completing the entry in Ridernet.

The volume of personnel for each competitor/team will be strictly controlled. Personnel not pre-registered for the event with ASBK will not be accepted into the circuit. Access to the circuit is only possible with the control event accreditation.

All competitors, entrants, and personnel are strongly encouraged to download the COVIDSafe App.

All vehicles entering the circuit are subject to security checks being conducted, please plan accordingly for your time entering the track, as this process is expected to be slower than usual.

Please cooperate with all new regulations and adhere to requests from security, ASBK Staff and Officials and Wakefield Park Raceway Staff. Any breach of the COVID-Safe restrictions may result in a sporting penalty and/or fines and penalties by government law enforcement.

6. Garages/Pit Boxes

All personnel in the ASBK paddock must follow the 4²m rule. All Pit Lane Pit Boxes will have a max of 5 people per garage allowed. Pit Boxes off Pit Lane may have a maximum of 5 people.

Competitors wishing to utilise their own tent/trailer and generator at the back of the paddock area may do so, please tick the option when entering via Ridernet and your location will be confirmed upon your arrival. Social Distancing and 4²m rule will apply to these areas.

Competitors/entrants are fully responsible for the management of personnel in their pit area under the COVID-Safe Plan. Any breach of the COVID-Safe restrictions may result in a sporting penalty and/or fines and penalties by government law enforcement.

7. Track Walk

Competitors are invited to inspect the track by walking only, social distancing of 1.5m must be adhered to at all times.

At ALL times be aware of the track crew vehicles that may be moving around the track setting up for the day.



8. <u>Tyre Allocation</u>

The ASBK Management Team can confirm the following Tyre Homologation volumes for ASBK Rounds 2 & 3 at Wakefield Park Raceway will be:

SBK	13 tyres
SSP	11 tyres
SSP 300	7 tyres
R3	6 tyres
OIC	As per OJC regulations

Tyre marking stickers for both rounds 2 & 3 will be provided to you at the same time from Technical Inspection. Riders & teams are responsible for managing their usage throughout both rounds with the tyre volumes advised above.

9. Race Format and Schedule

The race format for Rounds 2 and 3 will be as per schedule released by ASBK Management.

Race schedules are subject to change as determined by ASBK Race Direction.

Only Superbike and Supersport Classes Race 1 and Race 2 will have a media grid at ASBK Rounds 2 & 3. Social Distancing rules apply during the media grids. Media grids will be restricted to a maximum of 3 people per rider and media personnel only.

No media grid will apply for all other classes. All other classes will have a sighting and warm-up lap only.

Round 3 (Sunday) Qualifying Criteria - Superbike Class Rule Amendment to 2.7.3:

Superbike Qualifying positions for round 3 will be based on the overall Superbike round results from round 2 (Saturday).

The Top 9 points scorers from Superbikes round 2 will determine the competitors going into Qualifying 2. With the remaining riders go into Qualifying 1.

The fastest 3 competitors in Qualifying 1 have the option of entering into Qualifying 2. please note: no extra tyres are allocated for these riders.

The remaining riders will be allocated grid positions from 13th back, in descending order of times.

Q1 and Q2 – tyres will be marked.



10. Technical Inspection

Oceania Junior Cup technical and gear inspection will take place in the OJC pit box area

All other classes will be required to present their bike to Technical Inspection bay. Only one (1) person will be allowed per bike (competitor or crew) to present the bike for inspection. The rear stand must be provided by the team to complete ASBK Technical Inspection.

When in line up all teams must maintain 1.5m social distancing

Rider Gear should be presented by the competitor or a different crew member, one person per entry are permitted to present rider gear. 1.5m social distancing applies.

11. <u>Pit Wall</u>

Strictly on two (2) personnel per team will be allowed on pit wall, and only during the session or race of their rider.

Social Distancing must be adhered to in the signalling area. Teams must leave the signalling area when other classes are on track.

12. Parc Ferme and Podium Presentation

Parc Ferme and podium presentations will take place with 1.5m social distancing in place. Top 3 riders must enter the podium area. The rider + 2 crew member will be allowed in the podium. Teams are reminded that strictly NO hugging, handshakes or high fives are permitted under the COVID-Safe regulations.

13. COVID-Safe Requirements

The following are required to be adhered by all persons entering the circuit for ASBK:

13.1 Good Hygiene

- Teams and Riders must provide Hand Hygiene products to all team member under their control.
- Avoid sharing equipment or tools, and all equipment should be cleaned after use.
- Sharing of helmets and Rider Safety Apparel is strictly prohibited.
- No shared food, No cooking onsite, and No group catering services.
- Frequently touched surfaces, work areas and equipment are to be thoroughly cleaned on a regular basis. This is the responsible for these tasks.

13.2 Social Distancing

- Maintain social distancing measures of 1.5m between people.
- In accordance with the Sports Australia principles of '*Get in, play sport and get out*', all competitors, crew and officials should come to the event prepared and once activities have finished, pack up and leave each day.



6 November 2020

- The circuit and ASBK will put in place practical measures to enforce social distancing requirements, including the provision of signage and creating walkway barriers and/or markings that restrict the amount of people in any given area. All personnel must adhere to these instructions.
- Avoid unnecessary physical interaction between officials, competitors, media and other personnel. Wherever possible electronic interaction will be used.
- Essential buildings such as Race Secretary Office and Race Control, will have signage that clearly indicates the maximum number of people allowed. Within each room appropriate spacing must comply with social distancing requirements following the 1 person per 4m² rule.
- Race Direction will be a highly restricted room and no entry is permitted by Riders, Crew or Entrants.

13.3 Restrictions

Under **NO** circumstances should anyone with symptoms consistent with COVID-19 attend the event or travel. This includes any,

- fever
- respiratory symptoms
- cough

shortness of breath

fatigue

lack of sense of smell

- sore throat
- Under NO circumstances should anyone attend or travel to the event if they have been,
- overseas in the previous 14 days
- in contact with someone who has been overseas in the previous 14 days
- in contact with a known COVID-19 positive case in the previous 14 days
- within the last 14 days, have been unwell (including any respiratory symptoms)

13.4 Team Travel

Each competitor will be permitted a limited number of personnel. The competitor + personnel will create a small group for travel logistics as a "**Team**".

ASBK Teams are responsible for their own travel arrangements.

Each Team is responsible for creating an individual travel plan, incorporating its members and aims to minimise contact with other people, while conducting the COVID-Safe principles as is practical.

This travel period must adhere to the principles of a COVID-Safe environment, including but not limited to,

- Use of Hand Hygiene products and washing of hands
- No shared food
- Personal Protective Equipment (PPE) should be worn where appropriate
- Frequently touched surfaces to be thoroughly cleaned on a regular basis.



• Maintain social distancing measures of 1.5m between people.

Each Team is responsible for creating an individual accommodation plan, incorporating its members, which minimises contact with other persons and is conducting in the safest COVID-Safe manner practical.

Any accommodation option must adhere to the principles of a COVID-Safe environment, including but not limited to,

- Frequently touched surfaces to be thoroughly cleaned on a regular basis.
- Use of Hand Hygiene products and washing of hands
- No shared food
- Personal Protective Equipment (PPE) should be worn where appropriate
- Maintain social distancing measures of 1.5m between people.

When attending shopping centres, supermarkets, or restaurants during the event period or whilst in transit, all Teams are encouraged to minimise interaction with other parties and minimise the time spent outside of their accommodation option. Teams must always maintain social distancing measures of 1.5m between people and adhere to the 4²m rule inside all buildings.

All Teams must approach their travel and accommodation under the principle of creating their own **Team Travel Bubble** for the period of the event, inclusive of the period of travel to and from the event.

If during the travel period of any Team, should any member of the Team become unwell or develop any COVID-19 symptoms, that team member should contact the nearest Doctor, Healthcare facility or Hospital to seek further testing and care. All other members of that Team should then immediately seek COVID-19 testing advise and selfisolate until receiving further instruction from an appropriate healthcare professional.

Under NO circumstances should any of the Team attempt to attend the racing circuit venue if they are unwell for any reason or assume that heading to the circuit Medical Centre should be an option for medical care in this situation.

13.5 Site Management and Security

- Site Management will be coordinated by the Racing Circuit Venue and their specific COVID-19 Safety Plan
- <u>Only personnel who are pre-registered by ASBK for the event (which is restricted to approved personnel)</u> will be provided accreditation and permitted entry to the event.
- Social Distancing Measures must be adhered to by all personnel arriving at this area

14. ASBK COVID-Safe Event Information

The following information details which controls would be introduced to reassure the recommencement of the ASBK Championship in a COVID-Safe environment.



Additional Supplementary Regulations

(ASR) ASBK Round 2 & 3 – Wakefield Park Raceway

Based on a restricted numbers of persons onsite -

 All riders and teams are strongly encouraged to download the COVIDSafe App before the event.

- All personnel onsite MUST maintain social distincing of 1.5m in all areas.
- Hand hygiene facilities/products must be available at all toilet facilities and the food outlet.
- Hand hygiene facilities/products must be available at the entry and exit point of the venue and all the administration building.
- Riders and Teams are required to bring their own hand sanitiser, wipes, etc.
- No sharing of any bikes.
- No sharing of any equipment or tools.
- Competitors should wash hands before and after each activity and avoid touching their face.
- All personnel onsite will be educated on the COVIDsafe information and requirements prior to the event via email. Signage will also be provided at the venue entry and multiple other locations at the event.
- Personal protective equipment (PPE), hand sanitizer and wipes, should be available for staff and volunteer officials
- Regular cleaning of frequently touched surfaces provided by venue management
- No large gatherings, once riders have finished their activities then they should pack up and leave the racing circuit venue. Following the AIS principle of *"Get in, play sport and get out"*
- Prohibit non-essential personnel from entering the paddock.
- Limit the number of officials and support crew that can enter the paddock.
- Food catering outlets must operate according to government guidelines on social distancing, hygiene and maximum number of services allowed in an area.
- Takeaway Food only available from food outlet. Social Distancing must be respected at the food outlet
- No shared food
- Mark out spacing for areas where queueing needs to occur to create clear distancing between persons (1.5m). (Supermarket principles)
- No sharing of any rider safety apparel (helmets, gloves, boots, leather suits, etc.)
- Minimize and avoid use of indoor facilities where possible. All indoor facilities must have the maximum number people allowed in each room clearly marked with signage. The requirement of 1 person per 4m² must be adhered to.
- Buildings such as race control, media centre, medical centre etc, should have appropriate spacing of seats and signs indicting the maximum number of people allowed. The requirement of 1 person per 4m² must be adhered to.
- Competitor and officials to utilise self-printed forms where required and required to bring own pen. Pre-event education with the following materials via email and signage to be displayed at the venue.



- Podium presentations and Awards need to be in a controlled manner in accordance with government social distancing regulations of 1.5m separation. In the outdoor press conference style.
- Electronic payments only for transactions. Pre-purchase sales where possible.
- Under NO circumstances should ANYONE with symptoms consistent with COVID-19 attend the circuit. This
 includes any fever, respiratory symptoms, shortness of breath, sore throat, cough, lack of sense of smell or
 fatigue.
- Under NO circumstances should ANYONE who has been overseas in the previous 14 days or been in contact with a known COVID-19 positive person or person who has been overseas in the last 14 days, attend the circuit.
