It is a condition of obtaining a credential and a condition of entry to the 2024 MOTUL FIM Superbike World Championship, (Event) that it is acknowledged, agreed and accepted by the person to whom a credential is granted (Credential Holder) that;

(a) The use of this credential by the Credential Holder and their entry to and presence at the Event is subject to the published conditions of sale (<https://www.worldsbk.com.au/terms-conditions-2/>), conditions of entry displayed at entrances to the Event, these conditions and the conditions on the reverse of the credential. The Credential Holder further agrees, accepts and acknowledges that PI SBK reserves the right to refuse the Credential Holder entry with reasonable cause and that this credential remains the property of PI SBK.

(b) PI SBK may with reasonable cause require the Credential Holder to surrender the credential at any time and the Credential Holder must then immediately leave the Phillip Island Grand Prix Circuit by the nearest exit.

(c) CREDENTIAL HOLDERS ARE REMINDED AND AGREE THAT MOTOR RACING, THE EVENT AND CERTAIN ACTIVITIES ASSOCIATED THEREWITH (INCLUDING, WITHOUT LIMITATION, SUPPORT EVENTS) ARE DANGEROUS AND ACCIDENTS CAN HAPPEN.

Credential Holders are warned that there is a possibility of an accident causing injury, death or property damage or loss and your attendance at the Event is at your own risk. Credential Holders acknowledge that entry to and remaining at the Event has a degree of danger and, to the extent permitted by law, hereby exclude, release and forever discharge Fox Group Holdings Pty Ltd, Linfox Property Group Pty Ltd, Motorcycling Australia Ltd, PI SBK Pty Ltd, PI Circuit Pty Ltd, PI Operations Pty Ltd, 265 Ingles Street Pty Ltd, PI Visitor Centre Pty Ltd, PI Graydens Pty Ltd, PI Sunrise-McGuigans Pty Ltd, Federation Internationale de Motorcyclisme, Ambulance Victoria and Team Medical Australia, The Crown in right of the State of Victoria, Dorna WSBK Organization SRL, The Minister & Officers and Employees of the Department of Jobs, Skills, Industry and Regions (DJSIR) and all other persons involved in the organisation, conduct and promotion of the Event or construction or location of the facilities used in connection with or otherwise related to the Event and each of the respective officers, employees, servants, agents, sponsors, successors and assignees of each of the above from any liability for claims, loss, damage, costs or expenses arising in any way whatsoever from or connected with the conduct of the Event or my presence at the Phillip Island Grand Prix Circuit.

(f) The number and type of credentials given to the Credential Holder by PI SBK shall be given, denied or withheld at the absolute discretion of PI SBK and it may attach any conditions thereto.

(g) A credential accessing the campground does not give the holder the right to camp in any of the campground(s).

(h) PI SBK is not obliged to consider any application for a credential received later than 31st January 2024.

(i) Any vehicle Credential Holder acknowledges that, if the vehicle is parked otherwise than in an area reserved for parking for vehicles holding that credential type the vehicle may be towed away at PI SBK's absolute discretion and at the credential holders expense.

Collection Statement

Personal information may also be used for accounting and Event management purposes, for reporting incidents to Worksafe Victoria and other relevant authorities under applicable laws and for legal proceedings. Film and photographic footage may also be taken of persons attending the Event and may be used as set out in condition 21 of the Terms and Conditions of Sale available to view of our website www.worldsbk.com.au/terms-conditions-2/. If an applicant for credentials does not provide us with the personal information described above the applicant may not be issued with credentials for access to the Event and we may not be able to provide the applicant with information about products and services that the applicant may want, including information about discounts, sales or special promotions. The personal information we collect will be disclosed to the promoter of the Event, Dorna WSBK Organization srl (DWO), for the purposes specified above. We and DWO may disclose the personal information to our and DWO's employees, related bodies corporate, contractors and service providers and to insurance companies, medical or health personnel, journalists and media or public bodies or authorities, where appropriate. DWO is based in the European Union and accordingly this personal information will be transmitted outside Australia.
